SUPERVISION OF MINOR. MEDIA. On my own behalf, and on behalf of the Minor Participant, I consent to any photographs, video, or other media coverage of the Minor Participant while participating in activities at Louisiana Athletic Club.

ACKNOWLEDGEMENT OF RISK. I understand and agree that there are risks of significant injury to the Minor Participant, whether caused by the Minor Participant or someone else, in his/her use of or presence on Louisiana Athletic Club's premises. On my own behalf as the Parent/Legal Guardian, and on behalf of the Minor Participant, I agree to release and discharge from all liability, and waive all claims, demands and actions against, Louisiana Athletic Club, its affiliates, subsidiaries, officers, directors, employees, independent contractors, representatives, volunteers, and successors or assigns (collectively referred to as "Louisiana Athletic Club") for any and all injuries, harms or damages sustained by the Minor Participant in connection with their use of or presence on the premises, or their use of facilities, equipment, services, programs or activities within or outside its centers, resulting or arising from the negligent acts or omissions of Louisiana Athletic Club, or the negligent acts or omissions of me, the Minor Participant, other members, guests, visitors or other persons on the premises. I agree to defend, indemnify and hold Louisiana Athletic Club harmless against any and all claims brought by anyone against Louisiana Athletic Club related to such injuries, harms or damages.

CHILDCARE POLICIES & PROCEDURES

1. Childcare services are provided only while Authorized Adult is on the Louisiana Athletic Club premises.

3. Louisiana Athletic Club membership card or Government-issued picture identification will be required every time the Child is to be released from the childcare center.
4. For the wellbeing of the other children and staff, a sick child will not be allowed entrance into the childcare center.
5. Medications will not be administered by the childcare center staff.
6. Disruptive behavior will not be tolerated. In these circumstances, you will be notified immediately and asked to remove the child from the childcare center.
7. Louisiana Athletic Club reserves the right to withdraw a child from the childcare center for any lawful reason (e.g., inappropriate behavior, illness, or injury).
